

# Alliance for Zero Extinction (AZE) site protection helps meet multiple GBF targets.

## What are AZE sites?

Alliance for Zero Extinction (AZE) sites hold 1 or more [Endangered \(EN\) or Critically Endangered \(CR\)](#) species found nowhere else on Earth. Safeguarding this globally recognized subset of Key Biodiversity Areas (KBA) is essential to prevent species extinctions.

Protecting AZE sites has been **recognized by the [Convention on Biological Diversity \(CBD\)](#)** as a way to avoid imminent extinctions.

## Suggested steps

- Include AZE sites in NBSAP updates and 30x30 plans.
- Secure **funding** to protect AZE sites. Funding is available to establish or expand protected areas and OECMs at AZE sites through the [AZE Initiative Fund](#).

## Meet multiple GBF commitments

[Target 1](#): Including a map of AZE sites in your country's NBSAP helps to “*Ensure that all areas are under participatory, integrated and biodiversity inclusive spatial planning...to bring the loss of areas of high biodiversity importance... close to zero by 2030.*”

[Target 3](#): Protecting your country's AZE sites helps to “*Ensure and enable that by 2030 at least 30 per cent of terrestrial and inland water areas...especially areas of particular importance for biodiversity...are effectively conserved and managed.*”

[Target 4](#): By mapping and protecting AZE sites, you can “*significantly reduce extinction risk,*” directly contributing to meeting Target 4.

## Suggested NBSAP text:

“Alliance for Zero Extinction (AZE) sites incorporated into biodiversity-inclusive spatial plans, identified for expansion of protected areas and OECMs, and evaluated for their degradation status.”

“By 2030, the extinction of threatened species is prevented, and their conservation status improved through the development of conservation management plans, particularly for sites identified as Alliance for Zero Extinction (AZE)” sites.

**Suggested Indicators:** (1) Protected Area coverage of AZE sites (disaggregation of Protected Area coverage of Key Biodiversity Areas (KBAs): GBF Component Indicator; SDG Target 14 and 15 Indicator), (2) Regular management effectiveness (METT) assessment (GBF Complementary Indicator).
